Sir,

Bengal Homoeopathic Medical College & Hospital Ismile, Asanlol- 713301, West Bengal functioning since 1980, with intake capacity of 50 seats for BHMS course during A.Y. 2024-25. The College has submitted the Part 1 information in which the entire functional profile has been narrated. Medical Assessment and Rating Board has examined the profile of the college as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under the clause 28 of NCH Act 2020.

On careful examination of the report, the Medical Assessment and Rating Board has observed following shortfall.

**a). Hospital**

- I.P.D and O.P.D Case records should be maintained with demographic details of the patient such as Name, Age, Sex, and Address, Phone numbers etc. Diagnosis shall be written as per ICD 11 Criteria with complete case analysis, evaluation and repertorisation. These documents and follow up attendance of the patient shall be made available in the medical record room for academic purpose of students.

**b). Miscellaneous**

- Form 16 is not from Traces Portal. Copy of the same may be submitted for verification.

Considering the above observations and facilities available, MARBH has decided to Issue **Conditional Permission for functioning of Bengal Homoeopathic Medical College & Hospital Ismile, Asanlol- 713301. West Bengal with intake capacity of 50 seats for BHMS course during A.Y. 2024-25.**

All deficiencies noticed shall be rectified within a period of one month and compliance report shall be submitted for verification.

All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of 50 Seats for BHMS course shall be treated as All India Quota. Counseling for seats under all India quotas shall

Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

**Permission to the college can be withdrawn or denied in the subsequent year if the college is found deficient in Compliance to MSR 2013 anytime during the academic year**
